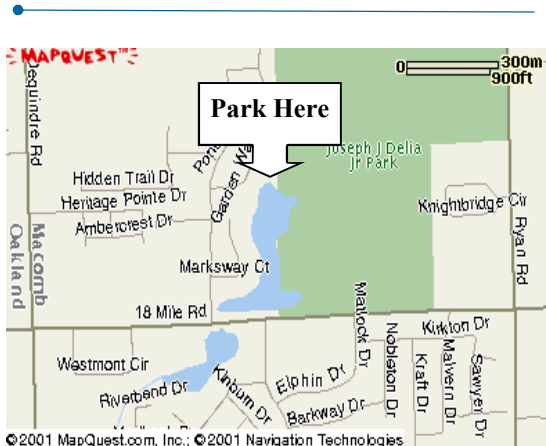

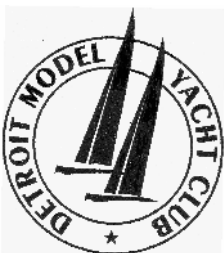
POND LOCATION
